The following exemptions apply to the *Commercial Vehicle Dimension and Weight Regulation*

1. The maximum weight limits for carrying axles fitted with two wide based single tires, each of which has a width of 445 millimetres or greater, are increased to:
 - a. 7,700 kilograms for single axles, and
 - b. 15,400 kilograms for tandem axle groups.

Note: This does not apply to steering axles.
2. The minimum track width for trailer axles fitted with wide based single tires is reduced to 2.3 metres for trailers built in 2009 or earlier. The minimum track width for trailer axles built in 2010 or later fitted with wide based single tires is 2.45 metres.
